

## 2016 Estimated Capital Gains Distribution Notice

### Oak Ridge Investments – Mutual Funds

Below are estimates of the capital gains distributions scheduled to be paid in December 2016.

Actual distributions will vary from these estimates based on the following:

- Estimates do not include final tax adjustments. Actual capital gains distributions will be affected by all required tax considerations.
- Capital gains are paid on a per-share basis. Changes in the number of shares outstanding could increase or decrease the amount per share.
- Estimates are calculated through October 17, 2016.

All investors who own shares, on the record date, of a fund paying a capital gain will receive the capital gain distribution on the payable date listed below.

Short-Term Capital Gains: Capital gain income from assets held one year or less and generally taxed at the investor's ordinary income tax rates in effect for the year. Long-Term Capital Gains: Capital gain income from assets held longer than one year and generally taxed at a special long-term capital gains rate.
